Peggy Borgstede and Kathy Green: Interfaith Task Force for LGBTQ Homeless Youth.

In 2005, Peggy and Kathy held their first forum of 100 invited guests to advocate for homeless LGBT youth. During that first year, the Task Force opened five temporary winter shelters in cooperating churches throughout NYC. The Task Force provided cots, blankets and pillows for approximately 40 youth. Over the next four years, they opened three permanent shelters. Trinity Place at Trinity Lutheran Church, NYC is still in operation. They have raised money, food and other necessities for youth at Sylvia's Place, Ali Forney and Streetworks (Safe Horizon)—all shelters and drop-in centers in NYC. They are now assisting Center Lane in their own city of Yonkers.

The Task Force's focus has always been LGBT youth. It is committed to advocating and educating others about the problems facing LGBT youth in today's society.
